OF CATEGORIES OF PRODUCTS NOT CLASSIFIED UNDER THE CATEGORY OF PRODUCTS FOR PERSONAL USE

- 1. Roes of fishes of sturgeon species in a quantity of more than 250 g.
- 2. Fish, crustaceans (live, chilled, frozen) in a quantity of more than 5 kg.
- 3. Ethyl alcohol, alcoholic beverages and beer with a total volume of more than5 litres imported by a person having attained the age of 18.
- 4. Ethyl alcohol, alcoholic beverages and beer transported by a person not having attained the age of 18.
- 5. Tobacco and tobacco products in a quantity of 200 cigarettes or 50 cigars (cigarillos) or 250 g tobacco or the mentioned products in the assortment weighing 250 g in total, imported by a person having attained the age of 18.
- 6. Tobacco and tobacco products transported by a person not having attained the age of 18.
- 7. The products exported from the customs territory of the Eurasian Economic Union (hereinafter referred to as "the Union") with respect whereto export customs duties have been prescribed by the legislation of the Member State of the Union (except for fuel in ordinary tanks of vehicles for personal use and in a quantity not exceeding 10 litres in a separate container).

- 8. Natural diamonds (except for diamonds worth not more than USD 75 thousand exported from the customs territory of the Union).
- 9. Vehicles which are not included in the list of certain types of motor vehicles and motor transports and trailers for motor vehicles and motor transports, which are vehicles for personal use, approved by Decision of the Board of the Eurasian Economic Commission No 74 of 30 June 2017.
- 10. Internal combustion engines (except for outboard motors of boats).
- 11. Central heating boilers classified under subheadings EAEU CN FEA 8403 10.
- 12. Machinery, mechanisms, equipment (except for mowers for lawns, parks or sports-grounds, non-professional circular saw) classified under headings EAEU CN FEA 8426-8430, 8433-8442, 8444 00-8449 00 000 0, 8453-8464, 8465, 8466, 8468, 8474-8480, 8486, 8514, 8530, 8534 00, 8535, 8545, 8548, 9024, 9027, 9030 and 9031.
- 13. Solarium for tanning.
- 14. Medical devices and equipment (except for syringes, needles, catheters, cannulae, similar instruments, equipment for measuring blood pressure, temperature, as well as apparatus necessary for medical use).
- 15. Medical, surgical, dental or veterinary furniture (except for hospital beds with mechanical fittings necessary for medical use).
- 16. Barbers' chairs and similar chairs, parts thereof.
- 17. Apparatus and equipment for photographic laboratories classified under headings EAEU CN FEA 9010.
- 18. Instruments, apparatus and models designed for demonstrational purposes classified under headings EAEU CN FEA 9023 00.

- 19. Games operating by coins, banknotes, bank cards, tokens or similar means of payment.
- 20. Products with respect whereto export control measures are applied, in the cases and under the procedure prescribed in accordance with the legislation of the Member State of the Union.
